During Instruction Bob will share with the participant(s) his experience and the techniques he uses to capture high quality bird/nature photographs. Instruction will typically include both classroom instruction used to prepare the participant for a field shoot, actual time in the field at a location chosen for optimal photo opportunities, and post processing instruction unless otherwise requested. Cooperative and photogenic species will targeted, at Bob's discretion, based on the time of year and location. While Bob is familiar with Canon cameras, participants should have a basic working knowledge of all their equipment before coming to the Tour/Instruction.

Tours/Instruction will begin at their scheduled times, regardless of participants' tardiness. Bob reserves the right to book or refuse any participant at his discretion.

Please be sure that you are prepared for any difficult terrain, long walking distances, and/or weather conditions. Any special dietary, allergenic, medical, physical or other needs/concerns/limitations should be communicated here:

Cancellation

The Tour/Instruction will be held rain or shine. Be prepared with proper rain gear for yourself and your equipment. All attempts will be made to stick to the reserved date and time, any deviation from schedule including cancellation will be at Bob's or the subcontractor's discretion should weather conditions or circumstances warrant. Trips cancelled by the participant within ten days or more of the agreed agenda date, will be Fully Refunded or rescheduled. Trips cancelled by the participant within less than ten days of the scheduled departure will loose their deposit; or if the full amount has been paid, the total less the deposited amount or the total less 25%, whichever is least, will be refunded.
